

ORDINANCE NO. 19-05

AN ORDINANCE OF THE COMMON COUNCIL OF THE TOWN OF GILA BEND HEREBY AMENDING THE TOWN CODE, MORE PARTICULARLY SECTIONS 31.043(M), 34.06(C), 34.07(B), AND 34.08(A), AS HEREINAFTER PROVIDED.

WHEREAS, the Common Council of the Town of Gila Bend in order to more effectively address current conditions and needs of the community hereby amend by update the following provisions of the Town Code;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE TOWN OF GILA BEND, AS FOLLOWS:

Section 1. That the Common Council of the Town of Gila Bend hereby amends the Town Code of the Town of Gila Bend, more particularly, Section 31.043(M) as follows:

Section 31.043 (M) Inventory and develop to the fullest potential any and all real estate and personal properties owned or controlled by the town. The Town Manager shall advise and coordinate all efforts in the development of the real estate holdings with the Planning and Zoning Commission. **In addition, the Town Manager shall make an annual inventory of all personal properties, and shall provide the same to Council.**

Section 2. That the Common Council of the Town of Gila Bend hereby amends the Town Code of the Town of Gila Bend, more particularly, Section 34.06 C as follows:

Section 34.06 C No fire apparatus or equipment shall be hired out or permitted to leave the fire station except **expressly approved in writing by the Town Manager or by contractual agreement approved by the Town Council, or** in response to a call for aid at a fire within the corporate limits of the town or in response to a call for aid at a fire in an area authorized for fire protection service or mutual aid under the provisions of Section 34.08.


Section 3. That the Common Council of the Town of Gila Bend hereby amends the Town Code of the Town of Gila Bend, more particularly, Section 34.07(B) as follows:

Section 34.07(B) In addition to the provisions of division (A) of this section, the Fire Department is authorized to attend fires at the request of the chief executive officer of any nearby community and to attend at the discretion of the Fire Chief. (deleted.... "any fire within a ten mile radius of the corporate limits of the town.")


Section 4. That the Common Council of the Town of Gila Bend hereby amends the Town Code of the Town of Gila Bend, more particularly, Section 34.08(A) as follows:

Section 34.08(A) shall be deleted in its entirety as currently coded, and subsection (B) shall be renumbered without a letter designation.


