

**ORDINANCE 20-06**

**AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF GILA BEND, ARIZONA HEREBY LEVYING UPON THE ASSESSED VALUATION OF THE PROPERTY WITHIN THE TOWN OF GILA BEND SUBJECT TO TAXATION A CERTAIN SUM OF EACH ONE HUNDRED DOLLARS (\$100.00), OF VALUATION SUFFICIENT TO RAISE THE AMOUNT ESTIMATED TO BE REQUIRED FROM LICENSES, FINES AND OTHER SOURCES OF REVENUE; PROVIDING A GENERAL FUND FOR GENERAL MUNICIPAL EXPENSES; ALL FOR THE FISCAL YEAR ENDING THE 30<sup>TH</sup> DAY OF JUNE, 2021; AND DECLARING AN EMERGENCY.**

**WHEREAS**, by provisions of the state law, ARS Section 42-17151, this ordinance levying taxes for the fiscal year 2020-2021 is required to be finally adopted by the Town Council accordingly; and

**WHEREAS**, the County of Maricopa is now assessing and collecting as the authority for the Town of Gila Bend, Arizona, the Town Clerk is hereby directed to transmit a certified copy of this ordinance to the Assessor and Board of Supervisors of Maricopa County, Arizona.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GILA BEND, ARIZONA, AS FOLLOWS:**


Section 1. There is hereby levied on the assessed value of all property, both real and personal, within the corporate limits of the Town of Gila Bend, except such property as may be by law exempt from taxation, a tax sufficient to raise the sum of Five Hundred Fifty Five Thousand Six Hundred Forty Dollars and 00/100 cents (\$555,640.00), for the purpose of providing a GENERAL FUND FOR THE TOWN OF GILA BEND, for the fiscal year ending on the 30<sup>th</sup> day of June, 2021.

Section 2. No failure by the County officials of Maricopa County, Arizona, to properly return the delinquent list and no irregularity of any kind of any proceedings shall invalidate such proceedings or invalidate any title conveyed by any tax deed; nor shall any failure or neglect of any officer or officers to perform any of the duties assigned on the day within the time specified work of invalidation of the assessment and levy of taxes or of the judgment of sale by which the collection of the same may be enforced or in any manner affect the lien of the town upon such property for the delinquent taxes unpaid thereon, and no overcharge as to part of the taxes or of costs shall invalidate any proceedings for the collection of the property under foreclosure; and all acts of officers de facto shall be valid as if performed by officers de jure.


Section 3. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

Section 4. WHEREAS, the immediate operation of this Ordinance is necessary for the preservation of public peace, health, and safety of the Town, an emergency is hereby declared, and this Ordinance shall be in full force and effect from its passage, adoption and approval by the Mayor and Town Council of the Town, and is hereby exempt from the referendum provisions of the Constitution and Laws of the State of Arizona.


